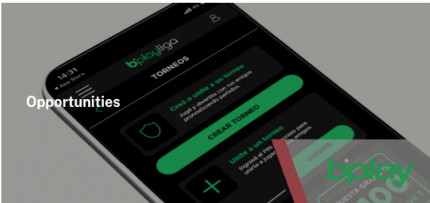
Who is the client?

2. It operates in several Argentine provinces offering sports betting, online casinos and regulated gaming.
3. The platform must offer a secure, user-friendly experience while meeting regulatory demands.

Main Challenges

1. **Regulatory compliance:** The Argentine online gaming regulation requires real identity verification before gameplay.
2. **Security and fraud:** the manual process posed risks of fraud, identity theft and document forgery.

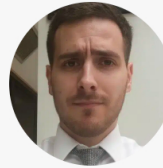
